Conversely, REX Attorneys was the successor of Maajar, Rwechungura, Nguluma & Makani, Advocates and Epitome Advocates. He is head Corporate, Tax and Insurance Legal Services Department of the firm. He practices in tax and corporate reorganizations, corporate consultancy, tax and commercial litigation, commercial arbitration, corporate re-organisations, liquidations and receiverships. He has a hard to rival experience in tax and general commercial litigation and arbitration and is held in high regard from the courts, clients, and peers. In 1997 merged with Pricewaterhouse to form PriceWaterhouseCoopers. In his capacity as legal counsel in PWC, Dr. Nguluma was responsible for commercial litigation especially tax cases and tax legal advice, commercial arbitration; providing legal and business support services to clients on company secretarial services, company formation and post establishment services such as obtaining business licenses, professional or specialized licenses, export/import documents; other corporate legal services such as negotiating, drafting and or reviewing legal



documents/instruments, for instance, joint venture agreements; know-how, licensing agreements; lease agreements; land conveyancing documents; shareholders' agreements; profit sharing agreements; debenture and mortgage instruments; guarantee agreements.
